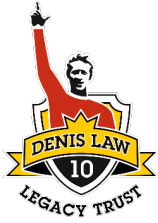
## **Disclosure exceptions**

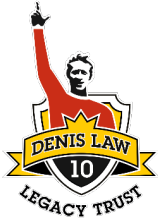
### **Security**

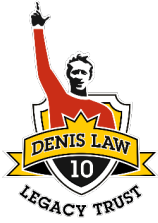
## **Mobile Terms of Service**
